Privacy Policy – Keeping your personal information safe.

This Privacy Policy explains how any personal information you provide on our website, including our teacher offer sign-up form is stored and managed.

This policy is designed to protect you, our users, by informing you what personal information is collected, what we do with that information, with whom we share it, and the methods we use to collect it. Your use of the Go Windermere website and any micro-sites is subject to your agreement with this policy.

Go Windermere is the public-facing brand of a consortium of businesses around Windermere in the Lake District. The businesses are Lakes Aquarium, Lakeland Motor Museum, Lakeside & Haverthwaite Railway, Windermere Lake Cruises, World of Beatrix Potter and Brockhole – Lake District Visitor Centre. Each unique business has their own strict privacy policy and procedures in place. This privacy policy relates to the data that is collected and shared from the Go Windermere website – www.gowindermere.co.uk and other marketing activities at tradeshows or events.

Go Windermere is proudly committed to complying with the Data Protection Acts 1988 and 2003 and any digital marketing efforts we undertake adhere strictly to its provisions. This privacy policy has also been updated to reflect the General Data Protection Regulation (GDPR) from May 2018.

Our website: Information we collect and how we do this

We use our website to provide accurate information about the six businesses around Windermere, link to their websites, and to communicate with you via web form/email and manage our successful scheme of free teacher taster days at all the attractions.

To help best provide a better service to you, we need to collect some personal information. This collection of this data is limited and voluntary and is intrinsic to providing e-tickets for the free taster days.

As a user of our website, you may opt-in to receive information from us, in which case we will require more personal data from you. We understand the importance of privacy and security and we aim to be totally transparent on how we collect data, what we hold and how it is used and stored.

Anonymous website data and conditions for using our website

Analysis of click trails

On Lakeland Motor Museum's website, IP addresses (the Internet address of a computer) are logged to track a user's session while the user remains anonymous. We analyse this data for certain trends and statistics, such as which parts of our site users are visiting and how long they spend there. We do not link your IP addresses to anything personally identifiable to you.

Cookies

A cookie is a text-only file that is placed on your computer by another computer on the internet to enable that computer to know when you are visiting a particular web site.

The use of cookies will enable us to monitor the number of people visiting our site and to determine the country of origin of specific users. We will not, however, be relying on the use of cookies - if you do not wish to accept new cookies or wish to disable cookies altogether, you can set your internet browser accordingly using its menu bar and this will not affect your use of our site.

Go Windermere does not use cookies, but we use Google Analytics to analyze web traffic on the website. They use the following cookies:

utmz		Keeps track of where the visitor came from, what search engine they used, what link was clicked on, what keyword they used, and where in the world they are when they accessed the website
